4.01.a. FCCLA-HERO Students

FCCLA-HERO stands for Family, Career and Community Leaders of America – Home Economics Related Occupations. FCCLA-HERO is a career preparation youth organization which focuses on service occupations. The organization focuses on the multiple roles of the family member, wage earner, and community leader.

Except for a small and forgivable break to attend the University of St. Thomas, nearly every year of Tom's life has been centered on the Robbinsdale Area School District since he entered kindergarten at (the former) Crystal Heights Elementary thirty-six years ago. After twelve years as a student and ten years as a physical education teacher and track, basketball, and soccer coach, Tom was elected to the presidency of the 1200-member Robbinsdale Federation of Teachers' Union in 1997, a post he has held ever since.

In July, this long association will come to an end as Tom begins a three-year term as president of Education Minnesota, the influential 70,000 member statewide teachers' union. Labor organizing is something of a family tradition for Tom, whose grandfather, Patrick

Corcoran, was secretary-treasurer of the Teamsters Union in Minneapolis in the 1920s and 30s. Corcoran was murdered for his labor activism in November 1937. Though Tom was born nearly thirty years later, he often cites his grandfather's life and work as his inspiration.
