REGULAR SCHOOL BOARD MEETING, EDUCATION SERVICE CENTER

January 7, 2002

1. Call to Order and Roll Call

Hernz called the meeting to order at 7:30 p.m.

2. Additions to Agenda

3. Acceptance of Agenda

Oetjens moved approval of the agenda with changes. Green seconded the motion and it carried unanimously.

4. Superintendent's Recognition

The superintendent recognized Jean Lipkin, a member of the We Care About Kids 2002 planning committee who shared share information about this event for families and youth.

4.01.a. We Care About Kids Day Proclamation

Community Ahead, a local coalition of volunteer adults and youth established to improve the assets of young people in communities served by Robbinsdale Area Schools, and coalition Chairperson Beth Brunstad, asked that the School Board of the Robbinsdale Area Schools approve the following resolution declaring Saturday, February 2, 2002, as WE CARE ABOUT KIDS DAY. Oetjens moved approval of the proclamation. Green seconded the motion and it carried unanimously. The proclamation follows:

WHEREAS, our local Community Ahead initiative is hosting WE CARE ABOUT KIDS DAY on Saturday, February 2 as a free family event to promote youth assets; and

WHEREAS, there are 40 developmental assets identified as the framework for healthy growth in our children, such as family support, bonding to school, making good decisions, resolving conflicts and feeling like life has purpose; and

WHEREAS, these 40 developmental assets will be the focus of WE CARE ABOUT KIDS DAY through the volunteer efforts of community businesses, resource agencies, faith communities and schools; and

WHEREAS, it is everyone's responsibility to build assets and help young people reach their potential; and

WHEREAS, we encourage all residents of our community to attend the event to build assets and inform themselves about community resources for families while enjoying free entertainment, demonstrations, a student art show, free food and the fourth annual District 281 Role Model Awards on February 2, from 10 a.m. – 4 p.m. at the Northwest YMCA in New Hope;

BE IT RESOLVED, that we are a school board that cares about kids; and

BE IT FURTHER RESOLVED, that Saturday, February 2 is declared WE CARE ABOUT KIDS DAY throughout the school district.

4.02. Arts Showcase
